Guidelines for a healthy workplace!

• Be sure that anyone cleaning in your facility is trained to safely complete the cleaning and disinfecting process, ask for certificates.

• Be sure surface cleaning is performed with a detergent-based cleaner before disinfecting happens.


• All touch points, not just the spots people are most likely to use, should be disinfected! Electrostatic sprayers can access the hard-to-reach spots that are tough to clean.

• Guard against cross-contamination by being sure that disinfecting happens from clean areas to dirtier spots, leaving the rest rooms and other highly contaminated rooms for last, and work from high-to-low to keep dirt from settling on low lying surfaces.

• If anyone suspected of carrying the COVID-19 virus was in your facility, the Center for Disease Control (CDC) recommends closing off areas accessed by the infected person for 24 hours before starting the cleaning process, reducing exposure to airborne germs. Outside doors and windows should be opened to increase air circulation.

• We recommend business owners should consider a disinfecting maintenance program with a reputable commercial cleaning company to ensure an ongoing healthy space for everyone who comes through your doors.
