Attorneys named to SuperLawyers & Top Lawyers of Berks County Lists

Additionally, the *Reading Eagle* newspaper named Mr. Wolf and Attorney Bruce Baldwin in their 2nd annual Reader's Choice list of Top Lawyers of Berks County 2022 — Mr. Wolf for Workers' Compensation and Mr. Baldwin in the practice area of Business Law.

Super Lawyers magazine uses a patented selection process of multiple phases to create their list of top attorneys in the state. The process starts with nominations by peers. These nominations are validated by third-party research across 12 categories. Candidates are then grouped into categories based on practice area and reviewed by those

attorneys who received the highest totals from each category. In the final selection, five percent of the state's attorneys are named to the Super Lawyers list, and 2.5 percent are selected to the Rising Stars list.

Mr. Wolf was previously named as a "Rising Star" in the *Super Lawyer* magazine in 2011 and 2012, and to the Super Lawyers list each year since 2014. In 2013, Mr. Wolf and Mr. McCabe became two of the first attorneys in the state to be certified as specialists in the practice of workers' compensation law by the Pennsylvania Bar Association's Section on Workers' Compensation Law as authorized by the Pennsylvania Supreme Court.

"It is very humbling to be acknowledged by my clients and my peers with these honors," said Mr. Wolf. "On its own I enjoy enormous satisfaction when I do a good job for my clients, but it is also nice to

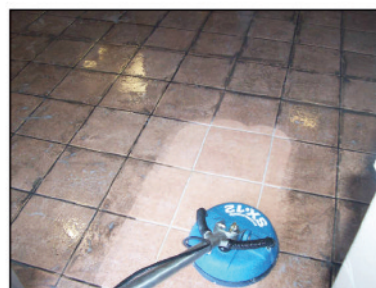
